Directions

From Upstate NY: NYS Thruway South toward Tappan Zee Bridge. Take exit 11. Make a left at end of ramp onto Rte. 59 east. Continue to first traffic light (Rte. 9W). Make left turn onto Rt 9W North. Park is 4 miles on the right. Take second (north) entrance into park.

Alternate route from Upstate NY: Route 17 East or NYS Thruway South to Harriman. From 17, take exit 130A, to Rt. 6 East (toward Bear Mt.) Continue on Rt. 6 to traffic circle. Take Palisades Parkway South to exit 13, Rt. 202. Turn left on Rt. 202 East (toward Haverstraw). Continue on 202 approximately 4 miles to Rt. 9W South. Take 9W South approximately 4 miles (at intersection of Rt. 303 in Congers, 9W turns to the left). Follow signs to stay on 9W. Enter Park at the first (north) entrance.

From Eastern Orange County: Route 9W South to Bear Mt. traffic circle. Continue south on Rt. 9W approximately 14 miles (at intersection of Rt. 303 in Congers, 9W turns to the left). Follow signs to stay on 9W. Enter Park at the first (north) entrance.

From Westchester and NYC via NYS Thruway: Cross Tappan Zee Bridge and take Exit 11. Go straight to traffic light. Turn left at light onto Rte. 9W north. Go 4 miles to park on the right. Take second (north) entrance into park.
